

Boarding School Regulation of Palucca University Dresden - University of Dance Dated 07.05.2010

By virtue of § 95 section 2 no. 4 of the law for higher education in the Free State of Saxony (Sächsisches Hochschulgesetz – SächsHSG (Higher Education Act for the Free State of Saxony)) dated 11th June 1999 (SächsGVBI. page 293) changed by article 26 of the law dated 28th June 2001 (SächsGVBI. pages 426, 428) and most recently by article 30 of the regulation dated 10th April 2003 (SächsGVBI. pages 94,97), the Principal of Palucca University Dresden - University of Dance passed the following Boarding School Regulation dated 07.05.2010:

§ 1 General Regulations

- (1) The boarding school is a facility run by the Palucca University Dresden University of Dance. The University is a corporation under public law and is therefore subject to all aspects of Jugendschutzgesetz (Children and Young Persons Act).
- (2) The opening times of the boarding school are based on the school and rehearsal schedule of Palucca University Dresden University of Dance. Any weekend or bank holiday opening of the boarding school is based on the University's schedule. The boarding school remains closed when the University is closed and during the school holidays in the Free State of Saxony.
- (3) Arrival after holidays is on the day before the start of term from 4.00 pm onwards, departure on the last day of term is by 6.00 pm.

§ 2 Regulations about behaviour in the boarding school

- (1) Every pupil/student has to check in/out daily after being at school/university (either using the register or informing the housemaster). This also applies if the pupil/student remains voluntarily in the school/university after lessons are out. If the pupil/student does not plan to immediately return to the boarding school after the end of lessons, then the housemasters have to be informed beforehand.
- (2) Room keys are picked up from the housemasters' room when returning to the boarding school and left there when leaving. The boarding school bedrooms have to be locked as soon as all occupants have left the relevant room. Cupboards have to be locked at all times.
- (3) Noise has to be generally avoided. Music players have to be set to a moderate volume. Please be especially considerate between 1.00 pm and 3.00 pm and 10.00 pm to 8.00 am.
- (4) Phone calls at night-time are not allowed.

Leave and start of night-time is based on the following overview:

The pupil/student has to return to his room at least 30 minutes before the start of night-time.

- (5) Visitors report to the housemaster or enter their details in the visitor's log.
- (6) If the pupil/student is sick or excused from class, then he has to report to the housemaster on duty. Whether the pupil/student can remain in the boarding school when sick is decided on a case by case basis. If the pupil/student cannot arrive at the usual time, then the housemaster on duty has to be informed by the parents by 8.00 pm on the day of arrival. Furthermore, the Palucca University Dresden's Sickness and Absence Regulation applies.
- (7) The pupil/student ensures order, cleanliness and safety in his room, the wardrobes, communal areas and kitchen. Individual food preparation on weekdays is not allowed.
- (8) Personal arrangements in the rooms have to be discussed with the housemasters beforehand. Moving furniture is not allowed. No stickers or similar must be applied to doors and wardrobes. Do not drill any holes or bring any additional furniture. Fabric bath mats are not allowed for hygienic reasons.
- (9) The pupil/student is obliged to observe housemaster decisions with regards to adherence of boarding school regulations and to follow relevant directives. In regular intervals and when required, additional instruction are provided which have to be confirmed by the pupil/student in writing. This applies specifically to adherence of order and safety including fire protection. Special incidents have to be reported immediately to the housemaster on duty.

§ 3 Fire protection

- (1) Smoking and handling open flames and light (including incense and pyrotechnics) are strictly forbidden.
- (2) Private electrical devices with a plug may only be operated in an operationally safe condition (test seal) and with permission by the housemaster according to "Accident prevention, electrical equipment and devices/GUV 2.10". Operating electric kitchen equipment (kettles, toaster etc.) is not allowed in the rooms.
- (3) The pupil's/student's legal quardians are liable for relevant TV/radio licence fees.

§ 4 Valuables

(1) Students/pupils can give valuables and larger amounts of money to housemasters for safekeeping. No liability can be accepted in the event of a break in or in a disaster situation.

§ 5 Commencement

This regulation comes into force on the day after being announced in the University. At the same time the boarding school regulation dated 18.07.2007 ceases.
